END OF YEAR REMINDERS

As another fiscal year wraps up, please take a moment to remind or familiarize yourself with end of year dates and best practices. To ensure that payments are processed as efficiently as possible, please submit cost-share payments in a timely manner. Payments are reviewed in the order they are received. Once we reach our appropriation authority, some cost-share payments may have to be rolled into FY26. When contracts rollover a change order must be created by changing the termination date to a date into the FY26 year. Rollover





change orders must be signed by both the cooperator and the board. FY25 rollover contracts in pending contract status will be given a new contract number. In addition, a MoSWIMS note is generated to indicate that the contract is a rollover. Contracts should be submitted by midnight June 16, 2025, with a status of PEND PO FIN in order to be paid in FY25.

Remember the contract payment review process allows the program to ensure that Missouri taxpayer money is used according to commission policy. During the review process, program staff try to remain as consistent as possible. It is important that districts include any relevant notes that would aid in the review process. For example, items that make the contract unique or clarify questions that may arise.

Due to the state transitioning from the OA Vendor form that we have used in the past to the Missouri BUYS powered by MOVERS, districts are encouraged to urge suppliers to register in the new system as soon as possible. The old forms will no longer be accepted in the near future. As a friendly reminder, prior to submitting contracts for payment please ensure that the EFT status is correct. When the EFT status is a green circle with checkmark, then that contract is ready to submit for payment. The program office cannot process payments that do not have an active EFT status and will have to return them. Another important item to note is that shared employees must have 200 hours outside their administrative district recorded in MoSWIMS by the end of the fiscal year to continue to receive the additional stipend from state funds. Any expenses for FY25, including payroll tax liabilities, must be paid on or before June 30, 2025. MOSWIMS should be unlocked around July 14, 2025.



ENVIROTHON RECAP



DISTRICT SPOTLIGHT

This year the district had a great turn out with 225 people in attendance at their annual meeting. Students who participated in the poster contest were recognized and provided with prizes for the top posters.
