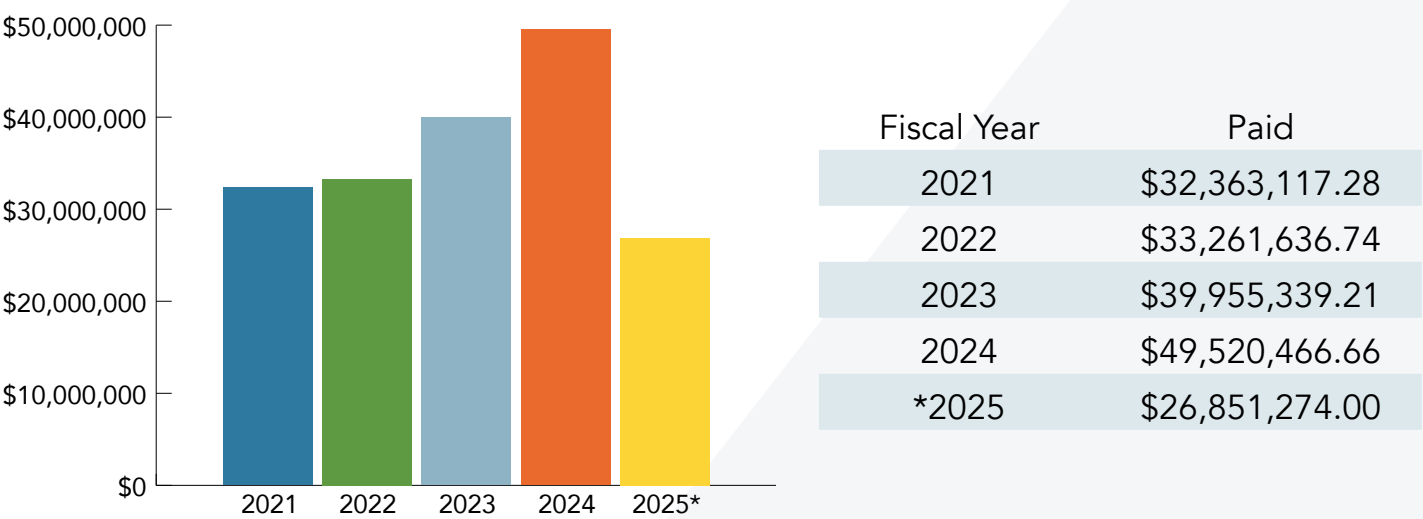

Soil and Water District Fiscal Year 2024 Summary

The Missouri Department of Natural Resources Soil and Water Conservation Program administers the policies and general programs developed by the Soil and Water Districts Commission to assist cooperators with soil and water conservation efforts on their farms by providing partial reimbursement through a voluntary cost-share program. Each of Missouri’s 114 counties houses a soil and water conservation district that assist cooperators in implementing the practices. The cost-share program is broken into seven resource concerns: grazing management, irrigation management, woodland erosion, pest and nutrient management, animal waste management, sensitive areas, and sheet and rill/gully erosion. There are 54 individual conservation practices available under those resource concerns. These practices provide many benefits to soil and water conservation efforts of the state by improving water quality through reducing sedimentation in rivers and streams, and retaining valuable topsoil by reducing soil erosion, protecting groundwater from nutrient loss and pollutants and properly recycling animal waste for use on agricultural land.

In the 1930s, as the Dust Bowl swept across the nation, relocating an estimated 300 million tons of soil, Americans realized the devastating effects of soil erosion. Legislation began to take shape to better manage and conserve the nation’s soil. Recognizing Missouri’s high erosion rates more than 80 years ago, Harrison County formed the first soil and water district, setting the stage for the soil and water conservation movement in Missouri.

In 1986, the Soil and Water Conservation Program implemented the one-tenth-of-one-percent Parks, Soils and Water Sales Tax, which has been voter-approved for more than 30 years. Up for renewal in 2026, the one-tenth-of-one percent tax is split equally between the Soil and Water Conservation Program and Missouri State Parks. Voters have the opportunity to vote on the tax every ten years. In the 2016 election, the tax renewal was approved by over 80 percent of voters, and passed in all 114 counties in the state. The tax is the main funding source for the program. The tax supports the cost-share program and the operational costs of the SWCP and districts.

The Missouri General Assembly approved an increase to the Soil and Water Conservation Program’s Fiscal Year 2024 cost-share appropriation from \$40 Million to \$50 Million in order to further assist Missouri landowners. In FY24, the SWCP paid 7,460 contracts covering more than 361,188 acres and saving more than one million tons of sediment and attached nutrients from leaving the field.

In addition to the normal cost-share assistance, the Soil and Water Districts Commission has identified a couple of targeted watersheds to increase assistance. The first is the Mozingo Lake project located in Nodaway County for conservation practices to improve the water quality of the sole drinking water source for the county. The second is focused on smaller watersheds within the Lower Grand Watershed in Putnam and Sullivan counties with emphasis on practices typically not implemented that will further address the sediment issue in the watershed.

Missouri Envirothon

Soil and water districts have been long-time supporters of the Missouri Envirothon, encouraging students to enhance their knowledge about the environment and Missouri's natural resources. The state of Missouri is divided into seven regions, and each region holds a competition in either the fall or the spring to select the regional winners. Regional winners advance to the state competition held in the spring, and the state winner advances to the national competition held in summer.

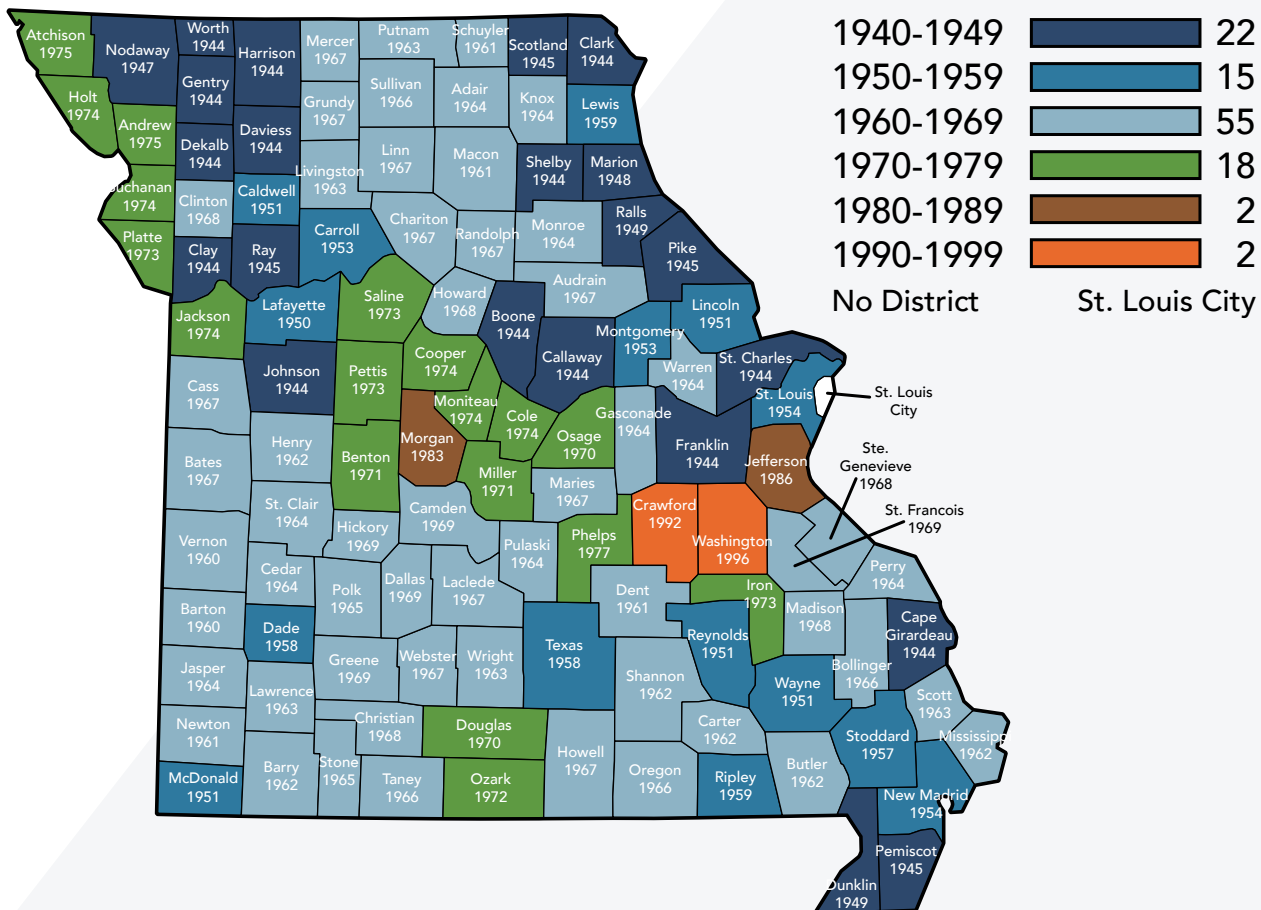
Teams of five high school students in grades 9-12 from around the state are asked to demonstrate their skills in the following categories: Aquatics, Forestry, Soils, Wild Life or Current Issue, in addition to an oral presentation topic provided by the NCF-Envirothon.

The State Envirothon Committee would like to thank all regional and state volunteers. Without the support of district sponsors and volunteers, this event would not be possible. The 2024 State Envirothon was held May 1, 2024, at Lincoln University's Carver Farms. Fourteen teams competed, with Rockwood Summit in St. Louis earning the top spot. Rockwood Summit represented Missouri at the national competition in Geneva, New York In July 2024.

Continuing Missouri Voter Approved Legacy of Soil and Water Conservation

In 1984, Missouri implemented the one-tenth-of-one-percent Parks, Soils and Water Sales Tax as a constitutional amendment with a sunset clause. Citizens also approved the tax in 1988, 1996, 2006, and 2016. Since 1984, the state cost-share program has assisted landowners in keeping over 190 million tons of soil from eroding into waterways.

The General Assembly's approval to increase the Soil and Water Conservation Program's appropriation authority several times has been crucial to the soil conservation efforts in Missouri. In 2014, the cost-share appropriation was \$27.7M with additional increases in 2015, 2016, 2017 and 2024 to the current cost-share appropriation of \$50M annually. The cost-share program is delivered through 114 local soil and water conservation districts with technical support from the Natural Resources Conservation Service and other partners. The cost-share program offers 54 different practices across seven resource concerns.

Since 2014, cost-share has excluded 424 miles of streams from livestock access, stabilized 10 miles of streambanks, constructed 6,687 miles of terraces, planted 1.4 million acres in cover crops, and converted 1,422 acres of cropland into field borders and filter strips.

Based on the modeling efforts happening in the SWCP, nitrogen loss reductions from these applied best management practices may be up to: 5.22 lbs/a for cover crops, 3.5 lbs/a for terraces, 6.1 lbs/a for field borders, and 5.85 lbs/a for stream exclusions. In addition, phosphorus savings range from .69 to 1.38 lbs/a for the same practices. With millions of total acres served, these modest savings add up.

Pairing Cost-share Funding with State-of-the-Art Monitoring at Mozingo Lake

In addition to regular cost-share provided to each of the 114 soil and water conservation districts in Missouri, the Soil and Water Districts Commission has targeted several special project areas of concern with extra funding for best management practices. One example is the Mozingo Lake project located in Nodaway County. Mozingo Lake is the city of Maryville's sole drinking water source and has a history of sedimentation and producing harmful algae blooms. This reservoir also serves many surrounding rural communities for a total of 30,000 people relying on it for drinking water and recreational opportunities. Since 2020, the commission has approved a total of \$448,880 for cost-share practices in the Mozingo watershed. So far, best management practices that address sedimentation and nutrient loss have been applied on more than 2,000 acres within the 13,064 acre watershed.

Thanks to a partnership with the United States Geological Survey, a state-of-the-art continuous water quality and stream flow monitoring system was installed into one of the tributaries to Mozingo watershed in 2021. This system measures turbidity, temperature, dissolved oxygen and nitrite levels of the incoming water at 15-60 minute intervals. The data will help establish a quality baseline for the water coming into Mozingo Lake. Another water quality monitor is located at one of the drinking water intake sites. As more best management practices are implemented on the surrounding farmland, the Soil and Water Conservation Program hopes to document the improvements in water quality.

Andrew County Soil and Water Conservation District hosts Conservation Kids Day at Ford Farm in Savannah. We invite all 4th grade students in the area. We have seven to eight schools with 250 to 300 students in attendance. The students are rotated through five stations. Natural Resources Conservation Service and Missouri Department Conservation along with local FFA members volunteer to do a short presentation. These stations are soil pit, poster contest/soil health, aquatics, wildlife and forestry. The students spend 20 minutes in each station. The soil pit station presents soil texture and horizons, and explains how soils develop. It also uses a rainfall simulator to show how soils erode if not covered. At the poster contest/soil health station they go over dos and don'ts on the poster, and how rain affects tilled and no till soils. At the aquatics station students learn about healthy aquatic environments. Animals from our district and their pelts are on display at the wildlife station. The forestry station explains tree density and species found in our district. We accept submissions from the county's schools for the poster contest. The contest starts locally with the potential of one poster advancing to the state level where it could be selected for the national contest. First place winners from each class receive a trophy, then all the first place winners from the county are combined and voted on for first, second and third place. Those winners receive a cash prize.

Cape Girardeau SWCD has seen some significant changes in the last couple of fiscal years that are worthy of recognizing. In FY22, the district paid out \$277,039 and in FY23, the district was able to pay out more than double the amount of cost share at \$512,552. The district was just shy of \$1 million in cost share for FY24.

"There's no denying that the increased workload is intense. We have found that staying organized and in clear communication is of the utmost importance," said Hannah Doolen, district technician.

There are several things the district attributes to the increased amount of cost-share spent. Having consistent, full time staff has been a large help, in addition to assistance from partner organizations.

"Collaboration with NRCS, MDC, and Quail Forever employees who have expertise in particular resource concerns has helped expand the practices we could engage in to benefit our landowners," said Doolen "Our county has the potential to utilize almost all the cost-share practices available but it is difficult to become an expert in all of them."

Cross-training is one of the tools the district uses to bolster its success. Cross-training allows the district staff to assist each other and keep things running smoothly if one of the staff members is unavailable.

The district is also very involved with the community, hosting the Cape Girardeau County Women in Ag event, annual public meeting and a Grazing Management and Native Warm Season Grass Pasture Tour in partnership with NRCS and MDC.

Christian County SWCD has several notable achievements, but the one they are most proud of is the perseverance and quality customer service they provided in a multi-year streambank stabilization project they were able to pay out in FY24. This project showed that sometimes it takes a while to build relationships and create solutions for landowners but in the end it creates a positive outcome for all.

The project involved stabilizing and excluding a stretch of creek located on an active dairy farm. Prior to contacting the district for assistance, the landowner made several attempts to fix the crossing on their own with little success. Accelerated erosion and livestock access to the creek were contributing to the degradation of the creek bank, leading to the landowner losing the ability to safely cross the creek with equipment, in addition to the erosion encroaching upon structures. The potential solutions to the problem were not an easy sell to the landowner. The landowner was hesitant to implement a project with so many safeguards in place, such as the fence and the 25- and 50 foot buffers, pipeline and tanks. Without intervention, streambank conditions continued to degrade, leading the landowner to make the decision to take the district's advice about success stories of other projects and apply it to his own situation.

"The plan was simple. Follow a certified engineer's streambank stabilization plan, install an approved creek crossing, add pipeline and tanks where permitted, put up the fence creating the necessary buffers and watch nature heal itself. The stream crossing is no longer affected by heavy downpours. The 25- and 50 foot buffer areas along the creek are full of vegetation helping hold the soil in place and filtering out runoff from the heavily used areas of the dairy farm," said Chance Phillips, a technician with the Christian County district.

The district is also in the process of getting back into the classroom with students to educate them on the importance of protecting our soils. Staff were able to spend time with the local Highlandville junior agriculture class to educate students about the importance of crop rotation and nutrient management through hands-on learning demonstrations. "It was a great experience for both the kids and us. One student made the comment that he couldn't wait to tell his grandpa about what he had learned. He said, 'he could really use this!' Hopefully, this is just one of many seeds that our district will be able to plant moving forward," said Phillips.

The Harrison County SWCD had a very productive fiscal year 2024 with several minor challenges along the way.

We had 128 cost-share contracts that claimed \$1,218,725.59 in cost-share dollars on 5,252.67 acres.

We offer 28 conservation practices to our county landowners, however, some are never utilized.

We also have available three no-till drills, a big bale mulcher, a Brillion Pulverizer, cover crop soil test rings, and some burn equipment for our landowners to rent. The drills were used on a total of 1,232 acres, the pulverizer was used on 217 acres, and the mulcher was used by 16 landowners on 19.5 acres during FY24.

We frequently measure drainage areas for road tubes for the county road and bridge crews.

Our staff has assisted with training and support to other SWCD staff members in Davies, Gentry, Grundy, Mercer and Caldwell counties.

The Howell County SWCD had a very successful FY24. The district set a new record for cost-share dollars spent in the county. The district paid out \$958,547.64 on 189 contracts. These contracts consisted of 13 different practice types in five different resource concern areas.

The district sponsored a South Central Missouri Cattlemen's meeting in conjunction with MFA. Topics discussed at the meeting included taking and reading soil tests, using soil test results to make fertilizer decisions, fertilizer types and usages, selecting and using agriculture herbicides, annual and perennial forage options and cost-share opportunities available through the Howell County SWCD. Over 50 local producers attended the meeting.

The district made significant upgrades to its rental equipment in FY24. The district purchased a new Haybuster 107c no-till drill and a new Haybuster 77C with a native grass box. The district also received a new Kubota pendulum seeder from the Missouri Department of Conservation and a Great Plains 1006 no-till native-grass drill from the University of Missouri Feral Hog Elimination Partnership. With all of these planting options available, Howell County landowners were able to seed over 3,350 acres during FY24.

The Howell County SWCD is focused on helping area landowners with all of their farming, forage production and management, and soil and water conservation needs. District staff attended, assisted with and participated in events including grazing schools, University of Missouri Extension workshops and events, South Central Missouri Cattlemen's Association meetings, Missouri Farm Bureau meetings, and a variety of other events put on by different groups and organizations.

Overall, FY24 was a great year for the Howell County SWCD and FY25 is shaping up to be even better!

In fiscal year 2021, the Soil and Water District Commission provided Nodaway County with \$200,000 for conservation practices to assist in improving the water quality in Mozingo Lake, the sole provider for drinking water to roughly 10,000 Maryville citizens, plus additional individuals in surrounding areas. COVID impacted our ability to spend funds, so we only obligated \$12,116.50 in FY21. In FY22, we were able to spend \$43,715.77, and for FY23 we spent \$44,660.13. We have \$22,037.38 contracted so far in FY24 with a total of \$122,529.78 spent to date. More funds would have been exhausted sooner, however, Mozingo Lake received enough attention to receive federal funding through an Mississippi River Basin Healthy Watersheds Initiative program, which has spent upwards of \$1.5 million to date on conservation practices within the watershed. We want to thank the commission for providing the \$200,000 for conservation practices!

On average Nodaway County SWCD provides producers \$1 million for terraces, \$150,000 for cover crops, \$150,000 for structures and \$15,000 for seedings. Producers are limited to receiving funding for engineering practices (structures and terraces) until the third fiscal year after receiving funds. Producers are also limited to either 133 acres for a one or two species mix or 100 acres for a three or more species mix. This allows us to provide funds to more and different producers each year. We utilize a lottery system for our structures and terraces. We recently decided to change our terrace process to a lottery system to make our office more efficient and effective. We have a week long cover crop sign up period the last week of July annually. Any producer that contacts us that week is guaranteed a contract. If producers contact us the following week(s) they are added to a waitlist, and if budgeted funds haven't been exhausted, then we obligate funds to producers on the waitlist.

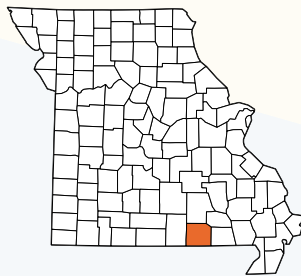

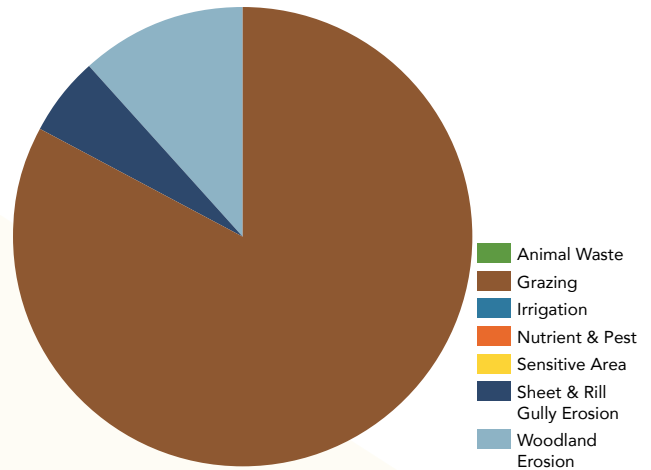

The Oregon County Soil and Water Conservation District had a fantastic year in FY24. Even though our district experienced staff turnover, our cost-share program ended the year as one of our strongest. Cost-share payments were made on 38 contracts totaling \$203,634.76. This resulted in assisting approximately 25 landowners in Oregon County. The county landowners received assistance in the following resource concerns:

- Grazing Management
 - o Payments totaled \$11,346.79 in this resource concern
 - o Approximately \$5,673.39 per contract
- Sheet and Rill / Gully Erosion
 - o Payments totaled \$168,772.21 in this resource concern
 - o Approximately \$6,750.88 per contract
- Woodland Erosion
 - o Payments totaled \$23,515.76 in this resource concern
 - o Approximately \$3,359.39 per contract

Educational programs are a powerful tool that the Oregon County SWCD uses to demonstrate the importance of agriculture. We take pride in hosting two programs that provide resources to multiple generations. The first educational program is our annual grassland evaluation pre-test, which was held Sept. 26, 2023, at J&S Ranch in Koshkonong. Students were provided a testing site for a mock grassland evaluation test. There were 77 students from eight schools who attended the pre-test. Afterward, lunch was served to the students, advisors, and assisting partner staff. The school advisors then had the opportunity to take their students back through the site for additional training.



10th Annual Farm Trade Show

The second education program was held Oct. 7, 2023, at Thayer High School in Thayer. The 10th Annual Farm Trade Show featured 50 agriculture-related vendors displaying their products. There were approximately 600 people in attendance from Missouri and Arkansas. Local businesses co-sponsored the door prize of a portable grain bin including the first grain fill up.

The Oregon County SWCD finished FY24 on a very positive note and looks forward to seeing how FY25 progresses.
