The Soil and Water Conservation program is pleased to announce the addition of an archaeologist to our staff. This new staff member will conduct archaeological surveys for both state cost and federal cost-share projects. Lee Johns was hired in February to fill this position.

## THE RESOLUTION PASSED... SO NOW WHAT?

Each November, the Missouri Association of Soil and Water Conservation Districts hosts their annual training conference for soil and water district staff, board members and partner agencies. This conference includes the association's business meeting, during which districts have the opportunity to present resolutions for consideration. Resolutions are then voted on and if passed by the majority of the voting body, the resolutions are provided to the program office. The program presents the resolutions to the Soil and Water Districts Commission, which then provides guidance to the program about how to proceed. Typically, the commission suggests that resolutions be presented to either the District Operations and Program Delivery Committee or the Cost-share Practices Committee. These committees consist of district staff, board members, partner agencies and program staff. After committee discussion, if the resolution in question needs commission approval, the program office takes their recommendation to a Soil and Water Districts Commission meeting for consideration. It is important to remember that not all resolutions result in policy change.


# **DISTRICT SPECIALIST TRAINING**

Like many organizations, Soil and Water Districts have experienced high levels of staff turnover. Here at the program, significant thought has been put in to how best to provide training to new staff in a uniform and efficient manner. While staff trainings are held in a group setting, this is not meant to replace one-on-one interactions. Group training sessions should be considered an additional tool for districts to learn from each other.

In November 2021, the first regional trainings for district staff were held. These district trainings are targeted for newer staff within their first few months of employment. They are also required training for district specialists to advance on the progression line. To date, 90 district staff have completed the training. Each participant is surveyed after the training and so far, there has been a positive response from attendees.

"The district specialist training was a helpful refresher on some of the original training I received during my first month with the district, a good way to pick up on some things I might have missed the first time through training," said Stefanie Thomas, Grundy County district specialist.

This training is geared toward administrative and policy topics, while NRCS takes the lead on technical training for district staff. The district training includes an overview of the program, district funds, quarterly report process, allocation and supplemental process, brief synopsis of the Missouri Sunshine law, audit process, lifecycle of a cost-share contract and includes time for discussion and questions. # **END OF YEAR REMINDERS**

As we head into the fourth quarter, there are a few things to note.

Please ensure that cost-share payments are submitted in a timely manner. This is important because contract payments are reviewed in the order they are received and once we reach our appropriation authority, some cost share payments may have to be rolled into FY24.

The program's cost-share appropriation authority for FY23 is \$40 Million. Each year the program allows districts to over-obligate or exceed the appropriation authority. This is because historically the program pays out approximately 87% of contracts that are obligated for various reasons, such as cancellations and roll-overs. However, in January, cost share was halted due to the high amount of obligations. In the last few days before the cut off, districts were able to obligate nearly an additional \$3 million, putting the total obligation at approximately \$49 million.

In addition to the above note, please remember that the contract payment review process allows the program to ensure that Missouri taxpayer money is provided to landowners in a timely and accurate manner. During the review process, the program tries to remain as consistent as possible. It is important that districts include any relevant notes that would aid in the review process, such as items that make the contract unique or information that clarifies questions that may arise.

The Cooperator Authorization form must be filled out accurately and list the correct name and address that is listed in MoSWIMS. Please remember to check the EFT status of contracts before submitting them for payment. The program cannot process payments that do not have an active EFT status and must return those payments.

In addition, please remember that shared employees must have 200 hours by the end of the fiscal year to continue to receive the additional stipend from state funds. Any expenses for FY23, including payroll tax liabilities, must be paid on or before June 30, 2023.
