# Native Grasses: Understanding the Why's and the How's of Drill Calibration, Establishment, and Management

This presentation will discuss why native grasses and forbs are important for cattle productions and wildlife. The presentation will discuss how to effectively establish natives, how to manage for them during establishment, and how to manage them for long term forage. Attendees will be able to learn how to calibrate a native warm season grass drill with an on-site drill. This presentation is perfect for anyone working with drills, those providing technical assistance to producers, and anyone who is asked or has interest in native grass forages.

#### Agricultural Safety for the Farm, Home, and Shop

Dan Downing, MU Extension associate professor, Water Quality Specialist, and Sustainable Ag. Program Coordinator will lead an update and overview of general agricultural safety considerations. The presentations and discussions will include content on farm equipment safety, livestock facilities (Shawn Deering, MU Extension Livestock Specialist), and other emerging areas.

Staff will also provide examples of best procedures and common issues identified through the accounting and quarterly report process. #### **Update on Applications of Drone Technology in Agriculture**

Kent Shannon, MU assistant teaching professor and MU Extension field specialist in agricultural engineering, will cover how drones have become an increasingly common feature of the agricultural landscape. Farmers can use unmanned aerial vehicles to scout for insects and disease, assist in planning irrigation strategies, collect information about crop nutrient needs and check cattle herds and fences. The latest use of drones includes the application of pesticides, specifically, fungicides, as well as, seeding operations for cover crops and wildlife food plots. This session will focus on real-life drone applications in Missouri agriculture research and Extension work through the University of Missouri.

The Soil Health Assessment Center (SHAC) will present an introduction/reintroduction to the role of soil health analysis in the DNR Cover Crop Cost Share Program. In addition to discussing soil sampling and the importance of survey data, SHAC personnel will present results, the new website, and the Soil Health Information Platform (SHIP). The SHIP program uses the accumulated soil and survey information to provide prescriptive information to land managers to use in evaluating their soil health practices and choices.
