



2017 Commission & Program Actions

- ✓ DNR/NRCS Joint SWCD Positions 27
- ✓ Comprehensive Nutrient Management Plan Funding

A flat rate incentive payment of \$2,000 for a CNMP completed by a Technical Service Provider for practices handling animal waste.

✓ Clarification for DSL-o1 Permanent Vegetative Cover Seeding on Cleared Land

To be eligible, the land must be in crop or pasture/hayland for 3 years prior to the DSL-01 contract.

✓ DWC-01 Water Impoundment Reservoir (pond)

Commission raised the cost-share maximum from \$10,000 to \$15,000.

Grazing School Funding Assistance

Offer a one-time grazing school incentive of \$75 at the time of contract payment for a landowner that implements a Grazing System practice.

✓ Increase the per acre maximums for Grazing System Practices for FY18

Practice	Current Max	New Max
Water Development	\$95	\$110
Water Distribution	\$85	\$120
Fence	\$60	\$70
Lime	\$50	\$50
Seed	\$40	\$40

- ✓ Variance to reconstruction policies for FEMA-4317-DR (48 Counties)
- Variance until December 31, 2017 in the declared area
- Reconstruction of soil and water conservation practices currently under a maintenance agreement; assistance on fence reconstruction at 50%; and group components to be paid based on individual components damaged
- Case-by-case basis variance to the no-till requirement in the N340 Cover Crop practice for the incorporation of sand deposits and smoothing areas of flood damage

- ✓ Variance to reconstruction policies for FEMA-4317-DR
- Allow landowners who repaired the practices under maintenance to receive cost-share provided they have appropriate documentation
- Allow the footage of fence that was damaged on practices under construction to be added to the cost-share contract at 50% cost-share
