Missouri NRCS Team,

As you are probably aware, the federal government may face a lapse in funding (shutdown) if Congress does not pass a funding package by midnight tonight. I want to take this opportunity to outline the implication of a government shutdown for our employees, partners, and offices, as well as give you a heads up on the procedures we must follow during such a situation.

#### Impact on Federal Staff

In the event of a shutdown, Missouri NRCS employees should receive notification if they are placed in furlough status or are exempt. **ALL EMPLOYEES** will need to report to their duty station the morning of Monday, March 17<sup>th</sup>, unless they are away on annual leave. Instructions will be provided on closing the office if we are placed in a furlough status. A furlough status means you will be in a temporary, unpaid leave status until funding is restored. During the furlough:

- You will not be permitted to perform any work-related activities, including answering emails and phone calls.
- You will receive retroactive pay once the government opens.
- Detailed guidance on the status of employee benefits, including health insurance, will be provided.

### Impact on Partner Staff

Partners who are co-located in USDA Service Centers will not be permitted in the office until a spending package is approved and the government returns to fully operational. Further guidance for partners will be provided if a shutdown should occur. Please ensure that co-located partners have received this information, and they understand the details. Please arrange lines of communication for changes regarding the office closure.

## Office Closures

If we are directed to close USDA Service Centers, we will follow specific procedures to secure our facilities and equipment, including:

- 1. Ensuring all confidential and sensitive information is stored securely.
- 2. Shutting down and unplugging non-essential electronics.
- 3. Locking doors and verifying that all entrances are secure.
- 4. Posting signage on the doors announcing the office closure (signage will be provided).

# **Preparation Checklist**

To ensure a smooth transition if a shutdown occurs, employees will report to their duty station on Monday, March 17<sup>th</sup>, to do the following:

- Set up outgoing messages on email and phones
- · Complete any outstanding tasks that may be time-sensitive
- Leave detailed instructions or notes for resuming operations once the office reopens
- Remove any perishable items from the office
- Shutdown and unplug any non-essential electronics
- Leave Government funded equipment (computers, cell phones, iPads, etc.)
- Make sure you have shared personal contact information with your supervisor and partners for communication on return to work

## What if I'm on Leave when the shutdown is announced?

If you are on annual leave at the time of the government shutdown, you have two options:

- 1. If you are on leave but at home, you must go to the closest USDA Service Center to drop off your government equipment, if you have it.
- 2. If you are out of state, you should return your government equipment to your duty station when you return.
