Kurt, Jim, and jim,

I had planned to discuss this in person with you all this morning at our planned meeting, but now it's going to have to be via email. NRCS is moving forward with offering another session of our newly developed Missouri Leadership Investing in Planner Success, or MoLIPS for short, starting late summer/early fall. The target audience for this course is NRCS staff and partners that are pursuing Level III Certified Conservation Planner designation. At the current time the DNR progression line does not require Level III designation to attain DS-IV pay grade, so there is no financial incentive for SWCD staff to complete the course and attendance should be based solely on employee development.

The course is a substitute for the previously offered Conservation Planning Part 2 training and it will provide credit for the following Aglearn requirements for Level III Certified Conservation Planner:

Prospective trainees should have some time in with their agency (>6 months?) and have completed all required prerequisites as outlined in the attached document. Having a basic understanding of the agency, conservation planning, and the employees' roles at the field office are important to successful completion of the course. This course will be delivered over an approximately 8-9 week timeframe and will require a significant time commitment on the employee's part; attending both online virtual presentations and local in the field training.

Again, this data call is only for SWCD employees who plan to attain the Level III designation. All training requirements to get to this Level are outlined in the two attached documents: Level 1 and Level III Planner Role Supervisor Certification. FYI, our Area Conservationists are compiling a list of NRCS staff needing the training but they WILL NOT be including SWCD staff in their reports.
