**Terms & Conditions**

- **A deposit of \$500.00** is due at the time of pickup. Deposits must be made payable to Chariton SWCD and can only be given to Chariton SWCD employees.
- The drill will rent for **\$15.00 per acre** with \$100/rental minimum. Acres are determined only by the acre meter on the drill. If the acre meter is reset by the renter, they forfeit their deposit.
- Rental of the drill will be for a maximum of 5 days at one time with the exception of weather. If the drill is not returned on the 6<sup>th</sup> day of desirable weather, your deposit will be forfeited and \$100/day will be added to the rental total until the drill is returned and inspected.
- No fertilizer or chemical are allowed to be used in the drill. If they are used, deposit will be forfeited.
- **Bill must be paid in full within 30 days after the invoice has been postmarked or your deposit will be forfeited.** Checks must be made payable to Chariton SWCD and can only be given to Chariton SWCD employees.
- Equipment must come back clean and empty of seed, greased and serviced or deposit will be forfeited.
- Renter is responsible for any damages or repairs done while checked out in their name.
- Renter is responsible for returning all parts/literature or deposit will be forfeited.
- The renter is responsible for transport to and from the USDA office.
- Equipment is allowed to be returned after hours but the office **MUST** be notified during office hours that equipment will be returned late and inspection of the equipment will take place the following business day.
- Equipment must be picked up during business hours to collect the deposit.
- Due to liability, Chariton SWCD employees are unable to hook the drill to renter's vehicle.
- **Renter is responsible for supplying a hitch pin. They will not be provided.**
- A 1/2 ton or bigger truck or 80 HP tractor is recommended to pull the drill.

*Lessee assumes all risk and liability for and shall hold lesser and its assigns harmless from all damages for injuries of persons and property rise out of the misuse, possession, or transportation of the equipment. Lessee, at his or her own expense will carry public liability insurance within minimum liability limits. Neither lesser, its assigns, the wholesale distributor, nor the manufacturer shall be held liable for any incidental or consequential damages that may result from any failure of use or misuse of this equipment.*
