1. I have received the drill operating manual. Failing to return the manual will result in a \$25 charge. _____
2. The drill will be used only in field capable of being mowed. _____
3. User agrees to lubricate the drill as recommended in the operator's manual provided. _____
4. User agrees to pick up & return the drill to the SWCD office, unless other arrangements have been made with Butler County SWCD personnel. _____
5. User agrees to repair any damage to the drill while in their custody, except normal wear and tear. User will immediately report needed repairs to the Butler County SWCD. _____
6. User agrees to the following while drill is in use: the tractor being used will be at least 40 horsepower, I will not make sharp turns with the drill engaged, and openers will be raised when turning. User will be responsible for any damage resulting from improper use. _____
7. The drill will be scheduled on a first-come first-serve basis. If weather does not permit use of the drill on the date scheduled, we will reschedule for the next available date. _____
8. The Butler County SWCD is not responsible for any seed lost and will not set the drill. The user is responsible for all settings based upon recommendations from the operation manual supplied to them. _____
9. The user is required to blow all tubes out with an air hose before returning to the Butler County SWCD office. There will be a \$100 charge if seed boxes/tubes contain any seed. _____
10. The user must rinse off any manure or mud before returning to the Butler County SWCD office. There will be a \$100 charge for returning a dirty drill. _____
11. The user will return the drill to the Butler County SWCD office by 9:00 am or there will be a late fee of \$25 per hour for every hour past 9:00 am, unless other arrangements have been made with Butler County SWCD Personnel. Full payment is due when the drill is returned. _____
12. User will NOT put fertilizer or lime in the drill. There will be a \$500 charge for cleaning and user will lose future rental privileges for this. _____
13. User will return all parts (pull pin, hydraulic ends, etc.) when returning the drill. Failure to return will result in user being charged for replacement of parts. _____
14. **The Butler County SWCD will not be liable for any accidents resulting from the transportation and use of this equipment. YOUR vehicle insurance is responsible for the equipment during transportation. There is a speed limit of 35 MPH during transportation. Vehicle pulling drill must be a full-sized pickup.** _____
