Terms & Conditions

- **A deposit of \$500.00** is due at the time of pickup. Deposits must be made payable to Chariton SWCD and can only be given to Chariton SWCD employees.
- The scraper will rent for **\$250.00 per day**.
- **Bill must be paid in full within 30 days after the invoice has been postmarked or your deposit will be forfeited.** Checks must be made payable to Chariton SWCD and can only be given to Chariton SWCD employees.
- Renter is responsible for greasing the scraper DAILY or more if conditions require. **Renter will pay damages of \$100 for each zerk not accepting grease when returned.** Equipment must come back clean, greased, and serviced or deposit will be forfeited.
- The lock pins on either side of the scraper must be used to hold the pan up during travel. **Renter will be responsible for any pins lost or holders broken.**
- Renter is responsible for any damages or repairs done while checked out in their name.
- Renter is responsible for returning all parts/literature or deposit will be forfeited.
- The renter is responsible for transport to and from the USDA office.
- Equipment is allowed to be returned after hours but the office **MUST** be notified during office hours that equipment will be returned late and inspection of the equipment will take place the following business day.
- Equipment must be picked up during business hours to collect the deposit.
- Due to liability, Chariton SWCD employees are unable to hook the scraper to renter's vehicle.
- **Renter is responsible for supplying a hitch pin. They will not be provided.**
- A 130 HP minimum (150 HP ideal) or 1 ton truck is required to pull scraper.

Lessee assumes all risk and liability for and shall hold lesser and its assigns harmless from all damages for injuries of persons and property rise out of the misuse, possession, or transportation of the equipment. Lessee, at his or her own expense will carry public liability insurance within minimum liability limits. Neither lesser, its assigns, the wholesale distributor, nor the manufacturer shall be held liable for any incidental or consequential damages that may result from any failure of use or misuse of this equipment.
