NO-TILL DRILL RENTAL AGREEMENT
WITH RULES AND REGULATIONS

7 FOOT TYE PASTURE PLEASER NO TILL DRILL

1. THE DRILL SHOULD NEVER BE TOWED AT MORE THAN 20 MPH. THIS DRILL WEIGHS 2600 POUNDS EMPTY AND SHOULD BE TOWED WITH AN APPROPRIATE SIZED VEHICLE.
2. PROOF OF AUTO INSURANCE HAS TO BE SUBMITTED.
3. THE DRILL IS STORED AT THE JCSWCD OFFICE. THE DRILL WILL BE PICKED UP AT THE JCSWCD UNLESS OTHER ARRANGEMENTS HAVE BEEN CLEARED THROUGH THE DISTRICT OFFICE.
4. RENTER/USER AGREES TO READ AND FOLLOW THE OPERATIONAL AND SAFETY INSTRUCTIONS BEFORE OPERATING THE DRILL.
5. RENTER/USER AGREES TO LUBRICATE SEEDER AS RECOMMENDED IN THE OPERATIONAL MANUAL.
6. THE DRILL WILL BE USED ONLY ON FIELDS CAPABLE OF BEING MOWED AND CONTAINING NO ROCKS, STUMPS OR OTHER DEBRIS WHICH WILL DAMAGE THE DRILL. THE DRILL WILL BE RAISED WHEN TURNING CORNERS AT THE END OF A ROW. THIS IS TO PREVENT DAMAGING THE DRILL AND IS VERY IMPORTANT.
7. WHEN TRANSPORTING THE DRILL, LIFTING CYLINDER BLOCKS MUST BE IN PLACE AND EXTRA CAUTION TO SECURE HYDRAULIC HOSES SHOULD BE TAKEN.
8. RENTER/USER AGREES TO PAY FOR ANY DAMAGES TO THE DRILL WHILE IN HIS CUSTODY EXCEPT FOR NORMAL WEAR. REPORT ANY DAMAGES IMMEDIATELY TO THE DISTRICT OFFICE AT 636-789-2441 EXT. 3. JCSWCD OFFICE HOURS ARE 7 A.M. TILL 4:30 P.M., MONDAY THROUGH FRIDAY.
9. SCHEDULING WILL BE DETERMINED BY JCSWCD ON A FIRST COME FIRST SERVE BASIS. PLEASE BE CONSIDERATE OF OTHER PRODUCERS. IF SOMETHING IS WRONG WITH THE DRILL, NOTIFY THE DISTRICT OFFICE IMMEDIATELY. IF YOUR PROJECT WILL NOT WORK AFTER YOU GET THE DRILL HOME, NOTIFY OUR OFFICE. SOMEONE ELSE MAY BE ABLE TO USE THE DRILL.
10. PLEASE RETURN DRILL AS SOON AS POSSIBLE WHEN FINISHED.
11. JEFFERSON COUNTY RENTER/USER AGREES TO PAY THE JCSWCD A FEE OF:
 - A.) \$50 DEPOSIT FOR 0-5 ACRES;
 - B.) \$50 DEPOSIT AND \$8. PER ACRE FOR 6-25 ACRES WITH DEPOSIT APPLIED TO COST
 - C.) \$50 DEPOSIT AND \$4. PER ACRE ON ACREAGE ABOVE 26 ACRES WITH DEPOSIT APPLIED TO COST

TYE NO-TILL DRILL RENTAL AGREEMENT CONTINUED

12. OUT OF COUNTY RENTER/USER AGREES TO PAY THE JCSWCD A FEE OF:

- A.) \$50 DEPOSIT FOR 0-5 ACRES
- B.) \$50 DEPOSIT AND \$10 PER ACRE FOR 6-25 ACRES WITH DEPOSIT APPLIED TO COST
- C.) \$50 DEPOSIT AND \$6 PER ACRE ON ACREAGE ABOVE 26 ACRES WITH DEPOSIT APPLIED TO COST

13. THE DISTRICT AND RENTER/USER WILL NEED TO READ THE ACRE METER BEFORE DRILLING BEGINS AND WHEN RENTER/USER FINISHES.

14. DEPOSIT WILL BE REQUIRED AT TIME OF PICK-UP. ACREAGE FEE WILL BE PAID UPON COMPLETION OF WORK.

15. NO FERTILIZER WILL BE USED IN THE DRILL. THE DRILL SHOULD BE CLEANED WITH EITHER AN AIR GUN OR WATER HOSE TO REMOVE ALL UNUSED SEED.

16. WILLFUL MISUSE OR ABUSE TO THE DRILL WILL RESULT IN ADDITIONAL CHARGES TO THE RENTER/USER.

17. WHEN STARTING TO DRILL, THE DISTRICT SUGGESTS STOPPING AFTER ONE OR TWO ACRES TO MAKE SURE THE DRILL IS SEEDING PROPERLY.

18. LIABILITY FOR ACCIDENTS RESULTING FROM THE TRANSPORTATION OR USE OF THES EQUIPMENT IS THE RESPONSIBILTY OF THE RENTER/USER AND NOT THE JCSWCD.
