NO-TILL DRILL RENTAL CONTRACT

RENTAL RATES:

7' Great Plains No-till drill @ office - \$12.00/acre in-county \$12.00/acre out-of-county
7' Great Plains No-till drill @ MFA - \$12.00/acre in-county - \$12.00/acre out-of-county
10' John Deere No-till drill @ Berrys - \$12.00/acre in-county - \$12.00/acre out-of-county
Minimum charge per use is \$100.00 in-county

TERMS:

Rental fees are billed to the renter. Payment is to be made in 30 days after billing. A \$250.00 deposit may be required at the time of rental. Renter agrees to pay all reasonable attorney's fees and legal expenses allowable by law, incurred by Renter in collection proceeding of past due accounts.

METHODS OF USE/RESPONSIBILITIES:

1. Equipment shall not be required for use until renter is ready for seeding (ground prepared, seed on-hand, etc.) **Barring weather problems and mechanical breakdowns, keeping equipment past reasonable time limits as judged by the District Supervisors, will result in a charge of \$50.00 per day.** Time allotted will be based on 30 acres per day.
2. DRILL WILL BE USED ONLY ON FIELDS THAT IS SUITABLE FOR CROP OR HAYING. Suitability of ground is at the discretion of the Warren County SWCD.
3. Renter agrees to pay for repair to equipment if damaged beyond normal wear and tear while in renter's custody. Damages payable to the Warren Co. SWCD.
4. Liability for accidents resulting from the transportation or use of this equipment is the sole responsibility of the renter and NOT the responsibility of the Warren Co. SWCD. Renter shall have at least the minimum liability coverage, as required by the state of Missouri, on the vehicle with which the renter will transport the drill over public roadways.
5. No one under the age of 18 years of age will be allowed to operate equipment.
6. MAKE SURE DRILL IS ALL THE WAY UP AND BE CAREFUL TURNING.
7. Must have tractor with minimum horsepower rating of 75 HP for John Deere drill and 55 HP for Great Plains drills.
8. Renter shall be solely responsible for all calibrations and settings required for seed type and stand failure with the exception of actual equipment malfunction.
9. Subleasing or moving this equipment between users is not allowed without the prior consent of Warren Co. SWCD.
10. Equipment will be inspected upon return to see if it has been cleaned properly, if not, a \$25.00 clean-out fee will be charged.
11. A copy of the renters insurance and driver's license has been furnished _____.
12. The drill shall be returned by the Renter on or before the ____ day of _____, 20_____.
