**EQUIPMENT RENTAL CONTRACT**

**RENTAL RATES:**

Vermeer Mulcher - \$100 minimum; 1<sup>st</sup> hour is free, \$50.00 each hour thereafter in-county  
\$200.00 per day; 1<sup>st</sup> hour is free, \$100.00 each hour thereafter out-of-county  
Needs 85 HP Tractor, 1000 RPM PTO units, Need 2 sets hydraulics  
Burn Equipment - \$10.00/day - Must have burn plan. Equipment must be returned completely empty of gasoline.

**TERMS:**

Rental fees are billed to the renter. Payment is to be made in 30 days after billing. Renter agrees to pay all reasonable attorney's fees and legal expenses allowable by law, incurred by Rentee in collection proceeding of past due accounts.

**METHODS OF USE/RESPONSIBILITIES:**

1. Equipment shall not be required for use until renter is ready to use. Barring weather problems and mechanical breakdowns, keeping equipment past reasonable time limits as judged by the District Supervisors, will result in a charge of \$50.00 per day.
2. Renter agrees to pay for repair to equipment if damaged beyond normal wear and tear while in renter's custody. Damages payable to the Warren Co. SWCD.
3. Liability for accidents resulting from the transportation or use of this equipment is the sole responsibility of the renter and NOT the responsibility of the Warren Co. SWCD. Renter shall have at least the minimum liability coverage, as required by the state of Missouri, on the vehicle with which the renter will transport the drill over public roadways.
4. No one under the age of 18 years of age will be allowed to operate equipment.
5. Renter shall be solely responsible for all calibrations and settings with the exception of actual equipment malfunction.
6. Subleasing or moving this equipment between users is not allowed without the prior consent of Warren Co. SWCD.
7. Equipment will be inspected upon return to see if it has been cleaned properly, if not, a \$25.00 clean-out fee will be charged.
8. A copy of the renters insurance and driver's license has been furnished \_\_\_\_\_.
