-COVER CROPS FY23-

Now is the time to start thinking about cover crops! The earlier you plan, the more choices you have. If you would like to participate in state cost share for cover crops, please follow these steps:

- 1. Decide what species you would like to plant and which acres you will plant them on.
- 2. Bring a farm map to the Soil & Water Conservation District describing the above.
- 3. Complete a RUSLE2 tillage information sheet.
- 4. Submit the Vendor Form and the Cooperator Authorization Form.

The application deadline for the cover crop cost share practice is November 10th 2022.

Please be aware of the following important information:

- Planting deadlines apply to each species selected.
- Cover crops <u>cannot be harvested.</u>
- Cover crops <u>CAN</u> be grazed (height limitations apply).
- Cover crops **AND** the following cash crop must be no-till.
- First time participants are required to send a soil sample to MU SHAC.
- Pettis County has a landowner limit of \$4,000 per year for the cover crop practice.
