Management Intensive Grazing School

We have scheduled our grazing school this year for May 9th & 10th. The school will be held at the Osceola Baptist Church 555 Walnut St. Osceola, Mo. Each day will start at 8:30 a.m. and will be over by 5:00 p.m.. You will be eligible to receive state cost-share funds to install a rotational grazing system after completion of this 2 day school. The cost for the school will be \$130.00. If couples or an additional person managing the grazing system want to attend, they will be charged an additional \$20.00 to cover food etc. The fee will cover the cost of instructors, all required manuals and materials etc. You must register with the SWCD by April 30, 2019 to attend. New Prescribed Burn Association In St. Clair County

In 2018, a group of landowners in St. Clair County and from surrounding counties met and formed the Upper Osage Prescribed Burn Association (UOPBA). The purpose of the UOPBA is for landowner members to help each other conduct prescribed burns on their property. Another important part of the UOPBA is to have adequate burn training and burn equipment necessary to complete the prescribed burns. The UOPBA is registered as a non-profit corporation with the Missouri Sec. of State. Recently, the association received a tax-exempt status under the 501(c)(3) of the Internal Revenue Service. A cargo box trailer has been purchased to hold burn equipment and currently burn equipment is being acquired. This organization was formed by landowners and is operated by landowners to get more acres prescribed burned for better forage and habitat in this area. Rental Equipment Available

The SWCD still has 2 Great Plains 10 ft. No-till drills available for rent. Both drills are capable of planting most seeds, and one of the drill's is also capable of seeding warm season grass seeding's. The rental fee for both drills is \$10.00 an acre for use in St. Clair county. The landowner will be charged a \$100.00 deposit with a 10 acre min. The drills can be used by landowners in adjoining counties for \$15.00 an acre, only if they are not being used by our St. Clair county landowner's and are sitting idle. We ask that the drills be used only on fields that are capable of being mowed for hay or crop ground, as rocky ground and stobs will damage the drills beyond normal wear and tear and the user will be expected to pay for the damages. We also have a 300 gallon pull type Schaben sprayer available for \$50.00 a day and Prescribed burn equipment for \$25.00 per day.
