### **Board Sets New Cost-share Policies**

At the November 3, 2020, Gasconade County Board Meeting, the Board of Supervisor's made some revisions to their current Board Policies for Cost-share.

- ✓ After some discussion, it was decided to establish sign-up periods for seeding practices in order to assist staff in allowing ample time for planning and designing of such practices. The Board took into account the seeding windows for the different species, as well as allowing for lime applications that must be given a 6 month window for any legume overseeding practice. The following dates have been established for the different type of seeding practices:
  - Spring Seedings to include grasses and/or legumes: August 15— January 15
  - Fall Seedings to include grasses and/or legumes: April 15—July 15
  - Dormant or Grazing System Lime (DSP-3.4)/Legume Overseeding (DSP-3.5): March 15—June 15
  - Cover Crops: May 15—September 15
- ✓ The Board will no longer limit the Streambank Stabilization practice to just rip-rap as there are new technologies being introduced. The Board will follow DNR Policy for cost-share payment limitations.
- ✓ The Board will follow DNR Policy for DSP-3 Grazing System acreage maximums and maximum Cost-share rates for DWC-1 Water Impoundment Reservoirs.
- ✓ The Board will raise the cost-share amount for a tire tank from \$600 to \$800 per tank.

## Managing for Wildlife on a Budget

Interested in increasing wildlife habitat on your property, but don't have a lot of extra time or money set aside for the project? Not a problem! There are numerous wildlife management practices that can make a real impact and won't break the bank or take up the entirety of your weekend. You most likely have all the resources on hand right now and don't even know it. No matter what size your operation is-5 acres or 5000 acres-you can make a significant difference!

Take a peek in any landowner's garage or shop around here and I'll bet you can find all the tools you need for these projects I'm referring to. A chainsaw, a lighter, and a little herbicide is all it takes to improve wildlife populations on your property. No matter if it's rabbits, quail, deer, turkeys, songbirds, or anything in between, they all benefit from early successional habitat (think annual forbs and grasses, blackberry patches, elderberry, etc.). In this FOSA's landscape, early successional is the one habitat type you could be lacking. Don't worry, a couple afternoon's work may be all it takes to turn that around.

The chainsaw is a great tool for increasing habitat on the cheap. Edge feathering is one of these practical practices that doesn't have to take all day and could make all the difference in your upcoming rabbit season. Have a gallon or two of extra glyphosate herbicide (Roundup) setting around the garage? For less than \$10 per acre you could turn something like an old fescue field corner into quality quail, rabbit, turkey, and deer habitat. Maybe you're like me and get a little stir crazy late-winter into early spring. Prescribed burning is a great way to get outside for an afternoon and set back plant succession, clean up woody sprouts, and increase wildlife habitat. All these practices I've just mentioned - edge feathering, fescue eradication, and prescribed burning - increase early successional wildlife habitat and take a minimal amount of time and money to complete.

### Gasconade County Resource Concern Spotlight Sheet/Rill & Gully Erosion

Gasconade County Maximum is \$20,000 per year/per landowner. Erosion must be above the tolerable (T) level.

- **DSL-1, Permanent Vegetative Establishment (Grass Seeding)** Assistance is authorized for lime and fertilizer, eligible seed, seeding operation and seedbed prep. Conventional tillage or the no-till method may be used for establishment. Soil Tests are required. Maintenance Agreement 5 years. **Signup period: Spring August 15 January 15, Fall April 15 July 15.**
- **DSL-2, Permanent Vegetative Enhancement (Legume Overseeding)** Assistance for seeding of legumes into permanent vegetation and for lime, phosphate and potash, and chemicals necessary to establish the legumes. **Lime is required 6 months in advance of a dormant legume seeding.** The legumes may be applied as a dormant seeding or drilled in the spring. Soil Tests are required. These fields must be able to show rest periods from grazing. Maintenance Agreement 5 years. **Signup period: March 15 June 15**
- **DSL-4/44, DSL-44, Terrace System** Assistance necessary for establishing terrace systems with or without tile is provided. Cost-share is allowed to convert an old system to a new system, if the present system is not serving its intended conservation purpose. Maintenance Agreement 10 years.
- **DSL-5, Diversion** Assistance for diversions, ditches, dikes, or subsurface drains where necessary for the proper function of the diversion. Maintenance Agreement 10 years.
- **DSL-11, Permanent Vegetative Cover on Critical Areas** This practice is used to stabilize critical areas such as gullies, banks, roadsides, field borders, and similar problems areas on farms. Assistance for measures needed to stabilize a source of sediment, such as grading and shaping, the establishment of grasses, including lime and fertilizer, mulching, trees or shrubs, or fencing to exclude livestock from new plantings. Maintenance Agreement 5 years.
- **DSL-111, Permanent Vegetative Cover on Confined Animal Feed Lots** This practice receives the same assistance as a Critical Area Treatment. It is used to address erosion problems associated with animal confinement areas, feedlots, hog pens, and other areas where livestock have been confined or allowed continuous access. The following requirements apply: Cost-share is limited to 5 acres per farm. The maximum cost-share is \$500 per acre not to exceed \$2500. Maintenance Agreement 10 years.
- **DWC-1, Water Impoundment Reservoir** \$15,000 maximum. This practice is to control active gully erosion and to provide water for agriculture uses and/or fire protection. Water Impoundment Reservoir practices must provide water source for livestock/crops as well as meeting erosion factor. They may not be constructed in heavily wooded areas or close to a residential facility. If some trees must be cleared, due to the bat population in our county, we are unable to construct a structure between March and October 31st. A watering system and fencing are required. Maintenance Agreement 10 years.
- **DWP-1, Sediment Retention Erosion or Water Control Structures** Structures such as erosion control dams (dry holes), de-silting reservoirs, sediment basins, debris basins, wascobs, or similar structures. Maintenance Agreement 10 years.
- **DWP-3, Sod Waterways** To establish waterways through site prep and establishing permanent non-woody vegetative cover. Establishment of berms and berm removal are a component of this practice. Maintenance Agreement 10 years.
- **N-340, Cover Crop** Provide operators an incentive to encourage the adoption of cover crops for reducing soil erosion, improving water quality and soil health. Applies to cropland acres where row crops are grown and soil erosion needs to be prevented or water quality and soil health improved. Acres must currently be in a minimum of 2 species production crop rotation. Cover crops must be no-tilled or broadcast seeded within the set time frame. The Production crop following the cover crops must be planted using a no-till system. The cover crop seeding must be planned with a minimum of 25% cool-season annual grass, small grain component or warm season grass. Payment of \$30 per acre for a 1 2 species planting or \$40 per acre for 3 or more species. There is a lifetime maximum of \$20,000 per operator. **Signup Period: May 15 September 15**


