

2018 Cooperator of the Year Bowe Family Farms



Casey and Jennifer Bowe purchased their first farm, located east of Laredo, in early 2003. That year the Bowe's moved to Trenton from Columbia. Both had attended the University of MO, Casey majoring in Animal Science and Jennifer earning a Doctorate of Medicine. They now reside on the family farm in Laredo that was purchased from Jennifer's mother, Peggy Scott, in 2008. The Bowe's have 3 children: Cayden (17), Hannah (14), and Catelin (8).

No-till has always been the primary method of farming used for the row crops. Since 2005 a majority of the row crop acres have been terraced with the assistance of state and federal cost sharing programs. This includes the ground rented from Casey's parents, Charles & Vickie Bowe.

In the last 5 years cover crops have been implemented. It began with 20 acres of cereal rye on corn ground that had been chopped for silage. For the past 3 years every row crop acre has had cover crops applied with many different crops utilized.

Besides crop farming they raise registered angus cattle. Breeding bulls and heifers are raised to sale as well as calves fed to finish.

What is a Management Intensive Grazing System?

Management intensive grazing (also known as rotational grazing management) is a system where grazing is managed to benefit both the livestock and forage. Livestock graze in each pasture long enough to harvest the forage, but are removed before too much leaf area is consumed. A basic system may have 4 or 5 pastures with more management intensive systems having 8 to 10 pastures.

Why should I attend this school?

The single most important management factor in determining the profitability of a livestock operation is keeping feed cost low. So why buy it when you can grow high quality feed yourself through a management intensive grazing (MIG) system?

Cost control, not the amount of production, separates profitable from unprofitable operations. Through a MIG system you can keep your cost low and in most cases production will increase, all while helping to conserve natural resources.

In addition to profits to your pocket book and the environment you may be eligible to receive costs share to help establish your MIG system. Check with your local SWCD or NRCS office for further information on assistance.

Kids Corner – Recipe Easter Eggs - Three Ways



Robin's Egg: To create the base color shown above, add two drops of green food coloring to standard blue egg dye, and then dye egg. Once dry, dip a fine-tipped paintbrush in a small bowl of brown liquid ink (available at craft stores) and splatter on the egg.

Paper Napkin Egg: Unfold a paper napkin and cut into ½-inch-wide strips. Use Mod Podge and a small paintbrush to adhere strips to the egg, lining up the pattern and trimming away any excess napkin. Once covered, let dry, then apply a final coat of Mod Podge.

Twine Egg: Use a small paintbrush to apply crafter's glue onto the top of an egg. Starting in the center of the top, wrap twine (we used four-ply) into a tight circle. Continue to brush on glue and wrap the egg until it is completely covered. (You will use approximately 12 feet of twine.) Trim excess.
