# "Watersheds: Our Water, Our Home" Theme Of 2018 Contests

It's that time of the year again for students to enter the annual poster and essay contests sponsored by the Maries County Soil and Water Conservation District. The theme for both of this year's contests is "Watersheds: Our Water, Our Home". Posters and essays should highlight that a watershed is land that sheds water and that the way we treat the land in our watersheds and our daily habits can have a big impact on the water that we drink.

Information and rules on both contests were distributed

to the Maries County Schools. The complete rules are also available at the district office.

The poster contest is open to 3rd to 6th grade students and the essay contest is available to 7th through 12 grade. Students must be enrolled in a Maries County School or home-schooled within the county.

A student may enter a poster or essay directly to the district office. Only one entry per student.

Cash awards, donated by the Maries County Bank, will be given to the top winners.

Entries should follow these guidelines when entering:


⇒The contest is open to amateur photographers and each participant may enter up to, but no more than five photos. **Entries will not be returned**.

⇒Black-and-white prints, color prints and prints from digital photos are all acceptable. Photos must be no larger than 8x10 and they are not to be framed and/or matted.

⇒The following information must be attached to the back of each photo. Include: **A. Photographer's name, address and**  phone number, B. Division and Category entered, C. Title of photograph, D. Subject Names, E. Location, F. Year of photo.

All entries become the property of the Maries SWCD, Previous entries will not be judged for the 2018 contest. There will be one winner in each of the three categories in each division. County winners will receive \$25 Cash and a framed print

# **Grazing School**

Gasconade County will be hosting the 2018 Grazing School at the Owensville VFW Hall on May 23 and 24. The school is a requirement to receive State Cost-Share Assistance for any of the Grazing Management Programs.

The school is limited to 30 participants. All applicants must be registered and paid by May 11th.

# **Cost-Share Sign-Up**

The district is taking sign-ups for their cost-share program where land-owners can receive a per acre incentive or up to 75% of the state average cost to implement certain practices. Some of the programs include:

- Pest Management (Spraying noxious plants/weeds)
- Pasture Establishment or Improvement (seed, fertilizer, lime soil test required)
- Woodland/Pond Fencing
- Well Decommissioning, Spring Development, Streambank Stabilization, Streambank Protection
- Grazing Management water source & distribution, cross fencing

# **FSA Updates**

## FARM STORAGE FACILITY LOAN PROGRAM (FSFL) HAS EXPANDED OPTIONS:

- FSFL expanded program now allows producers to obtain a low-interest loan for new or used
  equipment, in addition to previously allowed hay barns or grain bins. Examples of items now eligible
  for loan are: bale beds, grain trucks, grain trailers, hay trailer, skid steer, grain auger, hay wrapper,
  grain cart, gravity wagon, grain vac, round hay bale gripper, portable grain dryer, and pup trailers.
- 3, 5, 7, 10 or 12 year notes available up to \$500,000. Loan amounts less than \$50,000 only require 5% down payment.
- January Fixed Interest Rates:

3 Years: 1.875% 5 Years: 2.125% 7 Years: 2.250% 10 Years: 2.375% 12 Years: 2.375%

#### ANNUAL CROP REPORTING DEADLINES:

- 2018 grapes/apples/peaches must be reported by January 15, 2018
- 2018 spring oats & potatoes must be reported by May 15, 2018
- 2018 spring-seeded grains and CRP must be reported by July 15, 2018
- 2019 hay and pasture acres must be reported by November 15, 2018
- 2019 Fall barley, wheat and other fall seeded small grains must be reported by December 15, 2018

#### Agriculture Risk Coverage (ARC) & Price Loss Coverage (PLC):

• ARC/PLC is a financial safety net program that comes into effect when there are substantial drops in crop prices or revenues. Annual contract signing for 2018 began on December 1, 2017, and will continue until August 1, 2018. Producers who do not sign an annual contract will lose possibility of a payment for that year. Call the FSA office to check on the status of your contract.

#### NON-INSURED CROP DISASTER ASSISTANCE PROGRAM (NAP)

## March 15, 2018 is the deadline to purchase hay or pasture policies for 2018!

- Provides insurance coverage to producers who produce agricultural commodities that are not covered through standard crop insurance agencies.
- Provides financial assistance when a natural disaster occurs and causes lower yields, crop losses, or completely prevents the planting of crops.
- Some crops that may be eligible include fruits and vegetables, mushrooms, floriculture, forage, grapes, and grazing crops, aquaculture, ginseng, honey, syrup, and industrial crops.
- Traditionally Underserved and Beginning Farmers qualify for free CAT coverage, and 50% discounted buy-up coverage.
